- MD Child Care Mapping Tool
- DoIT update on MDiMap
- ??Bud→DoIT SaaS master contract is that the Esri contract?
  - No, the master contract for software was already procured. This is the software as a service and data service portion.

  - Geographic Names Board
    - A lot of activity in MD on the geographic names front
  - Washington County LiDAR derived hydrography project
    - 2400 scale
    - Statewide database for culverts
  - NAIP meeting at USGS next month
    - May bump up standard resolution, possibly to 1 ft; will be discussed
  - DC→NHD LiDAR derived hydrography project has entered production phase
  - Elevation Coordination
    - US Interagency elevation inventory updated
    - Count down has started for 2022 datum changes
  - NOAA has collected near short bathymetric data for St Mary's Co\_\_\_\_
  - ?? Bud→heard from Frank re: NHD for Washington Co. Was whole county the pilot or just western Washington Co?
    - Been a slow go; whole county will get done, but its been a difficult path forward

- Importance of relationship between Survey and GIS communities in Maryland
- ??John Knowlton→accuracy is often a misunderstood concept; context of checking data with regard to relative vs absolute accuracy.
- ??Roger Barlow—how would you apply scale to topics because it has to do with who within our professions represents the data.
  - Goes back to the intent of the data and what is being mapped.
- ??Bud→concept of intent is really important. Analogy of wedding photographer vs cousin with a cell phone. Might have photos, but won't be good photos.
- ??JB Churchill→is there any push towards or against surveyors using real world coordinates?
  - Two types of surveyors based on career timelines/attitudes and introducing the culture of sharing data
- ??Roger Barlow→use of metadata by the surveying community? Is it used? Is there a format?
  - There is plat metadata, but not widely used.
- ??Erick Pate—what is the educational path for a surveyor in MD?
  - CCBC is the only path in MD; two year school and then 2 more at Towson that are all geography classes.
  - MSS has an emerging program with high school students to establish internships for the students with private companies
