#### Financial recap

  - o \$23/3 months.
  - o Happy to continue.
- A suggestion that we get that expense on the books even though we will be paying him back.
- One \$10 reimbursement for overpaid membership dues.

## Status Non-Profit 501(c) 3 Corporation

- Still working way through with IRS and with accounting firm.
- Will need to refile the form 99.

## Collection of Dues / Membership (page 2 summary)

- 22 Organizational Members as of Monday: 12 Sponsors, 1 Organizational Level 3 (Salisbury University), 3 Organization Tier 2's, 5 Organization Tier 1's, 1 Individual Organization (Frederick County).
- 203 members included under those organizational memberships.
- 71 additional accounts are potentially eligible for organizational memberships.
- For example, ESRI has unlimited memberships but only one member currently under their organization.
- Salisbury University as an Organization Tier 3 will open up to all students.
- Will be encouraging other Universities to follow suit as ought to be a top priority for schools with a geospatial program to get their students involved.
- 46 Individual memberships.
  - o 10 are students.
  - o 15 are individuals that have not completed payment process.
  - o Mike emailed those folks yesterday and had 4 respond and complete.
  - o Now at 11 that have made it look like they wanted to be members but have not paid.
  - o 35 active individual memberships.
  - o 1020 active accounts remain in the system representing 261 organizations.
- There are about 42 individuals with unknown email addresses.
- Set email address to unknown for those whose information is known to be outdated but are kept in the system for them to update at a later date.

**Question:** Would these people really know how to log in? What if they do not know what email they used previously or their password.

- o "If you do not know your login information, contact Mike Scott"
- O Does not come up if user gets an error.

**Action Item:** Add to password recovery page.

o Give laptop at MSGIC booth system admin rights to allow people to login and update.

**Action Item:** Mike will create a dummy login for this purpose.

- Jim went in and updated MDP's information to have all their members added.
- Discussed previously SHA, DNR, Archive, MDE and a couple other agencies who had well over 100 MSGIC members who were not a part of an account.

**Action Item:** Mark will send completed letter to Jim that reaches out to organization.

Action Item: Barney to contact DNR and MDE and will put on MDiMap agenda.

- Wicomico reached out and wanted to get organizational membership had already had an individual pay \$50 and asked if they could use that \$50 toward an organizational membership.

- By-Laws
  - Data Subcommittee second draft
- Conferences
  - MACO: August 14-17 typically piggy backed on someone else's booth in the past.
    - Did not sign up any new members last year.
    - Bigger value being outside the exhibit hall.
    - May consider going every other or every 3<sup>rd</sup> year.
    - Rather encourage members to attend and representing MSGIC.
    - Could be wearing a "Ask me about MSGIC" button.
  - o DelMarva: May 8, Bridgeville Barney is keynote, Julia & ESRGC will be there.
  - West VA Association of GIS Professionals Conference: June 2-5, 2014, Charleston.
    - Rather Far conference and would be an overnighter.
  - o Annual Virginia GIS Conference (VAMLIS): September 15-16, Richmond
  - o Mid-Atlantic Chapter of URISA (MacURISA) October, New Jersey
  - o Maryland Municipal League (MML) June, O.C., Maryland.
  - o Consider sending one or two attendees to some of these.

# GIO Briefing - Barney Krucoff

- State is a member of NSGIC and looking at upgrading membership level to state council.
  - o Current membership has 5 members.
  - o This would allow any state employee to get on listserv
  - o Likely GIS staff would be identified by categories DNR GIS, EM GIS, etc.
  - o Would extend seats for MSGIC potentially include chair succession (past, current, and elect).
  - o A very useful listery if tracking state issues.
  - Previously discussed having past chair but with unlimited so could include 3 Executive Committee MSGIC members.
  - o Have always held 2 conferences a year but will likely go down to one annual.
  - o Conference in 2015 will go on as location has already been reserved.
  - Could look to send folks to conference.
  - o Similar purpose MSGIC/NSGIC good conduit for members to influence and shape industry.
  - o NSGIC has an annual advocacy agenda.
  - o EX: "Address Points for the Nation" Can't change census laws but can change process for collecting data.
  - o NSGIC will do the 3 MSGIC members unless
- MDP Budget of main importance.
- Senate Bill (644) Open Data Council.
  - o Takes two executive orders (MDiMap) and (Created md.data.gov council)
  - o Looks like it is going through with some minor amendments.
  - o Council will likely look at all data not just MDiMap.
  - Outside seats exist and some current will likely remain.
  - o Looking for both geographic and organizational diversity of members.
  - Likely this summer

- o Will add a House and a Senate member to the council which will make a more politically aware committee.
- o MSGIC should track and may want to nominate someone to council.
- o Ferguson and Barve sponsored bill.
- o Good for us as an organization to have these folks tuned into what we are doing.

#### Open Data

- o DOIT has reached a deal with Secrata Cloud service with data.md,gov
- Allows any locality in MD to have their own Secrata site that they can brand themselves up to 50 datasets.
- o Have two years that it will be available and then need to work out funding.
- Want to develop a number of dataset that the state wishes localities would post.
- o Localities need to agree to post a number of them.
- o May not need to be geospatial dataset, could be an excel sheet.
- MSGIC may work with localities to encourage them to participate and also help shape list of datasets.
- Looking for a unified ask.
- o Polled groups like MDE, MDP, etc., for data needs.
- o Cannot dictate field names would be pretty freeform.
- o Posting on locality site would also show up on data.md.gov site.

**Question:** When will the list of datasets together?

- Had a discussion at the last MDiMAP Technical Committee meeting and some initial datasets were thrown out, so can start an initial list.
- o Need to identify how much geospatial data vs non-geospatial data they want.
- Can search local governments data download pages there is a lot of commonalities of core data.
- StateStat may be interested in non-geospatial data not necessarily at the forefront of MSGIC.
- Making changes to MDiMap data catalog.
- Any data already on MDiMap has been gone through and is also on ArcGIS Online with descriptions and is searchable.
- New site will take any map service with multiple layers and will make one entry per layer making it searchable and downloadable in multiple formats.
- State agencies could publish to public pretty easily without going through MDiMap if needed
- o April 15<sup>th</sup> turning over keys to servers etc. to College Park
- New system allows for much more flexibility: separate layers, change draw order and will add to efficiency by cutting down number of services.
- O Anything that points to an iMap service is going to break at some point in the future. Announcing at TUgis that August 29<sup>th</sup> is that date.
- o Will work with state agencies on these issues.
- Will be running parallel systems and when in place will make hard sell to get organizations to point to new URL.

## Caucus – GIS Coordination Efforts and Local User Group meetings

- Local Government Updates *Matt Webb* 
  - o Put in jobs/internship requests to locals and have received some feedback.
- Regional Government Updates Mara Kaminowitz
  - Meeting coming up to go over survey
- State Government Updates *Erin Lesh* 
  - o Sent out similar email as Matt and has not heard anything back.

- May be having an issue with Outlook.
- o Caucus chairs have the ability to download csv of membership.
- List of State members will go down to active members after deadline which may improve responses.
- Need to come up with a way to reach out to state agencies as email communication is not working.

**Action Item:** Bounced back emails should be sent to Mike.

**Question:** Do we tag one of our quarterly meetings as an annual meeting?

- Will be Fall which is when elections take place.
- An annual meeting is required under our 5013c.
- This meeting should be promoted differently with a different format to include breakout sessions to be more interactive.
- Could include advocacy items for the year, Caucus on goings, etc.
- Can be difficult to get participation.
- Have recommended to MDiMap to have one group designated to give an update at each meeting to ensure they are heard from.
- o Need to change verbiage in bylaws as it relates to the fiscal year and annual meeting.
- o Fall meeting is in the Southern region.
- o Suggest switching Fall and Winter locations so that annual takes place in Central region.
- Suggestion make an Unconference Does not use typical presentation format.

**Action Item:** Mike to send info on an "Unconference"

- Federal Government Updates Roger Barlow
  - o Attended Denver International LiDAR Mapping Forum in February.
    - Corp of Engineers has a new tool call Coastal Zone Mapping and Imaging Lidar (CZMIL) for bathymetry.
    - Ability to penetrate turbidity greatly enhanced from existing instruments.
    - Roger will be monitoring for when reaches MD.
  - o Point Cloud Format (LiS) v1.4 released in coming months.
  - Two new classifications of LiDAR data (17)bridges and (18)birds and aircraft.
  - o Unmanned vehicles likely to be put on hold for many months and possibly years.
  - Outside of for-profit, Unmanned Area Systems are okay at low altitudes.
  - o USGS LiDAR funding:
    - Core Science Systems looking to reprogram some money for this fiscal year or next leaf off season.
    - Coastal areas are a top priority.
    - Kent and Talbott would be top two counties in Maryland to complete eastern shore.
    - President's budget (all LiDAR for 2014) was stripped out.
  - No update on existing LiDAR projects but will reach back out and forward info to Jim, Mike and Mark to redistribute.
  - Flash LiDAR Processing occurs on board the aircraft which greatly reduces turnaround time.
    - Initial results show results not quite as accurate but minimal.
  - Elevation Data Asked University of Maryland about use of their canopy LiDAR particularly in Garrett Co.
    - They have good point density and they will provide it to Roger who will forward it to Mike's group to see what can be generated from that.
    - Group that is doing that project is presenting today to the Smart Growth Coordinating Committee at MDP.
    - Have been pushing single photon LiDAR system that has higher point density.
    - Some from MDP group is attending.

- Advocating for an annual update of LiDAR to support Carbon monitoring Program.
- Density would be 6-10 times greater than we currently have.
- Originally recommended they not present on this very specific tool to this committee but because they have been talking to Governor's office on Green House Gas Lead group in state – MSGIC should know what is going on.
- o Garret County is the only full county in MD that has Marsalis Shale.
- o Roger will be moderating and presenting as a part of Federal geospatial activity at TUgis.
- o Have been unable to get work on Elevation Working Group but will restart.
- o Funding hydro flattening for Cecil & Queen Anne's County.
- Education Updates *Scott Jeffrey*

Not Present

- Private Industry Updates Marshall Stevenson
  - Sent out email promoting MACO
  - Will look into it more as it relates to Booth spot as they may be willing to work with us.

#### Miscellaneous

- Projects tab on website is leftover from old website.
- Consciously brought it over without updating in first pass of new website update.
- Organize this page to show what projects are supported.

**Question:** Can this page be used to show status of projects?

- Could follow MDiMap portal example which has an initiatives page.
- Theirs shows high level state-wide projects.

**Question:** Does their need to be a distinction between projects and those that MSGIC might be officially supporting.

- Projects makes it sound that MSGIC is executing.
- Should make positions clear that MSGIC has. Ex: Letters that went to Legislature.

**Action Item:** Erin will be content collector to begin page update.

- May want to look into going through something like Constant Contact to avoid emails getting caught up in spam filters.
- Cost to non-profits should be reasonable.
- Would benefit as we get to elections and voting.

#### Data Resources Subcommittee

- Subcommittee Meeting Recap Patrick Callahan
  - o Group met back at quarterly at Coppin State
  - Had an additional goal added.
  - o Will have more time to update mission statement and other tasks after TUgis.
- Statewide Imagery *Jim Cannistra* 
  - Google Imagery Conference call summary
    - Some locals were also on the call.
    - They are trying to get in on the digital ortho space by working with locals on acquisition contracts.
    - Google is trying to leverage existing imagery by providing data to state & locals.
    - Imagery refreshed every 3 years may or may not be leaf off.
    - Would be a service and may be provided in jpegs but would be one-off and have restrictions on use.
    - Also offering an oblique product.
    - Looking at a product 3-4 in res that competes w/Pictometry (GeoDigital Imaging) would be mostly leaf on.

**Question:** Do we have a sales rep from Google that deals with our region?

- Minash and another guy last name Evans. Barney last talked to Evans at NSGIC.
- Would not own imagery.
- Looking to sell software suite as opposed to data.
- Geospatial will eventually reach Google Docs email suite and want to be ready.

**Question:** Didn't Google ask for our imagery last year?

- Tried but became very complicated.
- Google moving toward not ingesting other data sources.
- Similar to Trimble Sketch up not taking any more buildings.
- Will be doing LiDAR and Flash LiDAR.

**Question:** For imagery in general – How are we going to share the imagery that we already have.

- We used to give to federal which allowed for some kind of download but no longer.
- Should use model following ESRGC and LiDAR
- o 2014 Western shore
  - Amount of time for snow to melt has caused some concern
  - Have gotten all the byups
  - Some are getting, high resolution 3", near-true orhos, planimetric updates, and so on.
- o Garrett County (NASA LiDAR project)
- o Budget for Property View
  - Holding steady.
  - Some concern that the overall state budget looking for money to make up for shortfall.

# Education Subcommittee – Lauren McDermott

• Held a conference call and decided on a survey that should go out before next meeting

# Grant Development Subcommittee – *Michael Scott*

- Primarily been dealing with membership.
- MHT (a part of MDP) received federal money for administering grants for Sandy relief.
- Some workshops will be happening.
- Mostly oriented toward redeveloping some buildings but also planning and analysis.
- Have heard about 4.7 million to install a jetty on roads point on Smith Island which will be below water in 60-70 years. May be a different grant.
- Graduate student at ESRGC looking at feasibility of enterprise GIS within the city of Crisfield and getting a good understanding of their capabilities.

**Action Item:** Jim will forward to Mike

Action Item: Mark to redo the Welcome Packet.

#### Outreach Subcommittee – *Ashley Buzzeo*

- Blog featuring Jim Cannistra and ortho imagery program just went live.
- Jim was able to provide content in a word document and shows "By Jim Cannistra".
- Would like to keep blog active
- Post from Mark and James on the datum.
- Can send invitation to our sponsors for content for the blog as long as not overtly commercial.
- Interview on Roger Barlow went out previously.
- Can do a recap from TUgis.
- Website Ashley has a handful of recommendations/suggestions for improving.

• Some examples include not having to dig for dues, projects, how to reach Executive Committee.

o If overall structure change should be brought to Executive Committee and small changes could be dealt with by group.
