## **GIO Briefing – Barney Krucoff**

MD iMap Executive Order Update

- Signed by the Governor
- Talk about that at TUgis Plenary session

### Budget Update

- Proceeding well
- DoIT hearings of agency budget was not controversial and GIS part not contested
- Governor's budget will go through is in good shape, at this time

### SDAT Stat

- StateStat meeting monthly to potentially put together SDAT Stat
- Forum to improve the process, cross purpose datasets identified (change detection), provide comment
- Focus is tax and revenue, not mapping, but mapping is a component
- Potential sub-committee to provide feedback to this group from GIS community

Addressing pilot with Census Bureau and USPO?

- Barney to sit on a pilot design state representation
- Project to create an address data sharing exchange model between local, state govs, USPS and Census Bureau to improve accuracy and sharing
- Work to give local governments heads up of this potential in the future to mobilize taking advantage of this potential opportunity
- NTIA work and GIS budget might allow for opportunities for statewide addressing in the future

## **MAPPS** Meeting

- Organization interested in how state do contracting, how states buy things
- Primary concern about Maryland is university competition
- Potentially good allies with MSGIC
- Interest within MD firms to create a MD chapter
  - Stems from Exec Order with a MD chapter this group could be on the MD iMap Executive Committee board
- New chapter is a pretty significant step lobbying efforts would be more significant
  - Wrote a letter to Barney with 8 or 9 points of concern
    - Hit many of the points already dealt with by state
    - Contracting work to prison industries
    - Create state land's inventory
    - Qualifications based procurements

- University competition
- Want influence/voice on contracting as private sector organizations
- Some concerns are legitimate and some concerns were not legitimate (perception vs. reality of the current situation)
- This group has impacted how USGS has conduct business in contracting
- Very aggressive Executive Director
- 2 letters sent to the Governor of Maryland received a generic letter of viewpoints
  - Response from Governor through Barney has been posted on their website as first response
  - Showing that MD is willing to talk
- Suggestion of what we want to be with them: lots of good investments left to make (critical area maps opportunity to grow this (one example))
- Suggestion also about partnering with private and universities
- Encourage them to attend open meeting MD iMap and MSGIC and try to get at least 1 private sector presentation at each MSIGC Quarterly meeting
- PlanMaryland Presentation by MDP with Maryland Society of Surveyors (MSS) in 2 weeks

## **MSGIC Reorganization Progress Report – Chris Slavin**

Paperwork to file

- All together; state filing ready to go
- Still need the money to submit this How do we get these dollars?
  - There were a number of folks interested in contributing to this
  - Solicit donations for this amount
  - Start with executive committee and go from there
  - \$170 to file for the state and \_\_\_\_ to rush (\$220 all together)
  - Trying to file this next week
- Liabilities moving forward have been discussed with an insurance agent
  - Workman's Comp insurance required to pay anyone, including interns
  - Numbers are based on per member number
  - No insurance company will write a policy unless projected financials are provided, which would come from dues collection
- Dues Membership
  - Drafted a survey to poll people to see how much they would be willing to pay in dues
  - Need to be clear on what people will get out if they are paying dues
  - Questions in poll about the benefits of paying membership fees
  - California GIS Committee are also a non-profit (501c3)
    - Manage GIS conference for the state
    - They pay URISA to do the conference for them
    - They do charge dues
    - They have sponsored GIS awards (companies and jurisdictions can be awarded)
    - They use PayPal to collect dues

• Hired an accountant for year-end reporting and other financials for when they apply for special benefits of being non-profit

Question: Personal Property Tax form and Form 990 have to be filed every year to IRS

- Exempt from tax, but have to keep list of assets
- Haven't decided when survey will be sent out
  - Should this be reviewed by the group before this is sent out
  - Get draft out to group to review next week or just send it out as-is
  - Promote it out to membership with reminder for quarterly meeting and gives them this same window to respond
- Level of dues (Private and Individual) more issues with coming to events as an individual membership (paying out of pocket)
  - Some counties will participate in group level and some won't
  - Supply several avenues for membership
- MSS: several membership levels (Associates, Students, Sustaining Members) -\$1,000 a year for a group like MSS to participate (3 – 5 seats come with this membership), this could be extended to the local jurisdictions
- Need to get the fee structure setup

Action Item: Kenny Miller to provide NSGIC structure of membership

- All of this is going to require by-laws changes and current changes haven't yet been put in place
  - Should we go to membership and get this all approved at once?
  - Should we get the first round of updates in place and then spend some time discussing the next round of updates?
  - Solicit corporate donations and this would be our financial picture for this upcoming year and then next year the financials will change and the insurance policy will be updated
- Not convinced we need liability insurance we are participating as part of our organizations Kenny Miller
- Don't envision getting interns involved in the immediate future which would need this insurance coverage – Kenny Miller
- Grow into the model as we continue to grow the resources and reliabilities of the new organization Kenny Miller
- Will there be conflicts of interest if not all organizations are solicited for donations and some of the organizations that might be contracted with these donators
- Board must be made aware of conflict of interest, sign a policy and recuse themselves from related decisions (board of directors would need to sign this)
- Requirement for filing the paperwork, new incoming members have to sign
- Move toward getting structure in place (couple of tiers of sponsorship corporate, state agencies, local agencies) – Jim Cannistra
- Then take the approach of dues and levels through the upcoming year Jim Cannistra

- Structure passed and approved before moving forward with some of these other updates and changes to the organization
- By-laws should include whether people can vote, should include dues structure
- Sponsorships do not have to go into by-laws come up with a structure and implement quickly
- Continuing working on process to get survey out preface with MSGIC exploring possibilities and nothing has been decided – drive the decision to be made
- "Our Subcommittee" to come up with a framework on structure of dues
- Call for nominations for next year's elections
  - Encourage people to run for new positions that are out there
  - Email blast now and have nominations by April quarterly (30 days before elections) potentially – deadline for mid-May for nominations
  - Have discussion at quarterly meeting about the new positions
  - Setting the precedent for how elections should run into the future
- Filling of Elizabeth Stahlman's position Regional Caucus Co-Chair (no action needed between now and July b/c there is 1 chair) no need for a special election

## MSGIC Coordination – Data and Resources Subcommittee – Ashley Buzzeo

Review of <u>www.marylandgis.net</u>

- MMRG site has been around for a while and is not being updated all that much
- Is this still necessary?
- Recommend: A lot of historical information that should be moved to other sites, some things can be abandoned get a group of 2 3 people who have legacy with this, go through site to determine what needs to be kept and where it should be redirected
  - Short-term redirect to new site
  - Google Maryland and GIS this site comes right to top (re-direct approach) for interim period of time
  - Redirects to: MD iMap? MSGIC?
  - Information that doesn't want to be lost from this site (metadata, etc.)
  - MSGIC Executive Committee is an appropriate place to decide what should happen when someone hits marylandgis.net – suggest MD iMap Portal site and on this site add some of the historical information so it isn't lost
  - More of the content would go to the MSGIC site than the MD iMap site, but how do you blend the redirect of the information?

Action Item: Kenny Miller to take the lead for small group to decide and report back at the next MSGIC Executive Committee meeting (Chris Slavin offering to provide local input)

- Where does data.maryland.gov plan stand? one data portal for the state
  - Might need an interim solution so content from MMRG is not lost
  - Idea exists and StateStat Office is taking lead, software package has been purchased (Socrata) Baltimore City, State of Washington have worked with this tool
  - StateStat Office is going to start with data related to StateStat process
    - Mechanism to map datasets, Esri partner, but with own unique viewer
    - Started, but no master plan about where the process will be in 6 12 months

- Kristen Ahearn is the lead from StateStat Office
- Format of the data is important
- Another version of an existing database (.csv instead of .xls) these workflow issues have to be sorted out
- Will apply to state data as a start, but the plan is the make this available for local data sharing in the future
- What should the interim solution be? redirecting to new homes

### MSGIC Communications – Education and Outreach Subcommittee – Scott Jeffrey

Newsletter

- Still working to get this out
- Do we need a new plan to get the newsletter out?
- Communication plan is needed as one of the things that members receive this information
- Put together a blog which is updated more often and key articles are pulled together quarterly to include in newsletter
  - Add new tab and embed blog into website
- Format and timeline were put together, but not implemented
- To use Chris Slavin's newsletter format from last year to move forward with new newsletter
- Try to have something together for the booth at TUgis to handout in print

## Website (New Content)

- Need to move away from DNR as host of website
  - Recreation of website could happen at same time as moving to msgic.org URL
  - Coordination will be needed to complete this
  - Solicit volunteers to take on putting together this new website
    - Pool resources that would be able to work together to create new website

- Short list highlighting MSGIC member presentations highlighted on 1 document
- Track people down and have arcgis.com website up to try and get people to check info while they are at the booth
- Balloons to be put up at booth

GIS in Business Conference – May 25, 2012

- Sending out and soliciting people who have worked in ArcGIS world and non-profit world for presenters (honorariums for presenters)
- Some money available to pay speakers who might come in to speak with CCBC students
  - MSGIC as clearinghouse for speakers
  - Connection with CCBC could provide some funding

MACO Summer Conference, GIS Discovery Zone - Marshall Stevenson

- 8 booth spaces (vendors CGIS, SSA, Pictometry and Esri) 8 spaces to sell for involvement
  - Looking to keep this going and get some new people/groups involved
- August 15 18<sup>th</sup> (Wed Fri) Ocean City, MD
- Marshall to send out emails of past participants to solicit this year's participants
- Are there things that need to be changed? Are there things that need to be done differently?
  - Is there a way to put a banner across the entire group so that it points out the GIS Discovery Zone this would be an extra charge (requires convention center staff to set this up)
  - Have in the past to place vertical signs on the corner to delineate the area
  - Could you put down a different color carpet for the 8 booth space, so it stands out from the other colors surrounding it
  - o Balloons and helium tank available from Sandi Stroud
  - Should MSGIC itself have a booth? they won't donate a booth, so it will need to be paid for
    - Esri in the past has gotten 2 booths and donated a portion to MSGIC
      - Action Item: Marshall Stevenson will ask if a booth can be donated to MSGIC
      - Is this an effective way to communicate what we are trying to do?
      - Would need to consider how to staff this booth
  - Timeline for booth decisions nothing specific at this time
  - Win the booth decorating contest gets a free attendance for the following year
- Accessing the elected officials at the local level helps them understand what GIS is and what it can do helps the local GIS managers do their job

  - On Governor's desk and awaiting signature
  - Ideally signature will be obtained before TUgis 2012
    - Marketing and communication to follow signing
- ArcGIS Online Premium, Google Earth Builder & Socrata Demo/Presentations
  - Each organization provided the group presentations on the capabilities of their products
  - Discussion to conclude how to proceed resulted in:
    - Moving forward to participate with ArcGIS Online Premium via ELA

- Moving forward to participate with Google Earth Builder in a pilot capacity with MDP & MDtA
- State has already purchased basic-level product
  - Training will provide a better understanding of GIS data sharing options through this product
- SwGi & ArcSDE
  - Discussions have started about updates to configurations necessary to more effectively and efficiently share data via SwGi (intranet)
  - New configuration will assist with providing agencies a secure environment to share sensitive data internally and facilitate collaboration between agencies
  - Cost savings for those agencies which utilize resources through the intranet rather than an internet connection
  - $\circ$  Considering configuring a solution where a read-only SDE model
    - Still in early stages of this part of the discussion
    - Other options still being considered
- MD iMap Infrastructure
  - All parts and pieces of MD iMap have been upgraded to Version 10
- Mobile Applications
  - Mobile application for Portal has been released (<u>http://www.mdimap.us/imapmobile/</u>)
  - Mobile application for GreenPrint (<u>http://www.mdimap.us/greenprintmobile</u>)
    - Built with HTML5 and JavaScript
    - Expect to make template and code available for others to build mobile apps

- Doesn't reflect 2012 currency but most recent data available
- Garrett Co completed official conversion project
  - Wrote a letter to Appalachian Regional Council who funded some of QAQC about getting funding through partnerships with multiple groups, cooperative work with multiple agencies – nice feedback
  - State will be responsible for distribution of this data outside of groups working with the county
- Working with 8 9 counties with integrated parcel work for 2012 addition product

## Ortho Fly-Over – Jim Cannistra

- Everything is delivered (Western Shore)
- Everything reviewed by counties and independent QAQC major milestone
- Into final data distribution effort (8 9 counties received data)
- Final corrections and getting data on drives
- Input for need/desire for 2013 Eastern Shore fly-over solicit feedback at Spring Quarterly
  - D.C. might consider flying in 2013 would statewide be considered?
  - Some counties are interested in flying in 2013 (Western Shore), but some aren't as interested or need data again this quickly
  - Open this discussion for funding/project collaboration
- Providing counties with .SID, .jpg files (.tiffs and other formats, as requested)
- Set going to USGS for distribution (.tiff drives)

- Howard & Calvert has been closed out data provided to USGS and DNR for distribution
- Salisbury to create 2m DEM from this product
- Map service of Worcester County data available via Salisbury University
- 1 foot contour generation for Worcester Co is the next product delivery from SU
  - Flight to acquire Wicomico/Somerset delivery 7/31/12 (Arc 122<sup>nd</sup>)
  - Discussion of doing Dorchester next (funding dependent)
- Carroll County data received
  - Putting data together again to determine if pieces or tiles are missing
  - SU will resolve this issue
  - Metadata file is available and has been forwarded on to SU
  - Looking to put together DEM as derivative product that could be distributed
  - Airborne 1 collected Carroll County data
- Garrett, Allegany, data collection updates to be coming (FEMA & NRCS funded)  $1/9^{\text{th}}$  Arc second
- Jet Propulsion laboratory's considering LiDAR collection for land cover project out of University of Vermont to find more information
  - D.C. going to request that 100% of the city be captured (90% captured in proposal)

- Missed on previous acquisition added to VA FEMA non-era acquisition
- In queue to be added to dataset in April coming soon

- DNR to be distributor of the outcomes of these data collections including local efforts
- Statewide DEM at a consistent resolution for 8 digit HUC watershed to be attempted in the future SU has created this as the data has become available and then determine how to distribute, b/c it is a large file
- 3D services available at V10.1 from Esri concerning the available LiDAR data being collected for the state

- CGIS a key partner that has developed a template to upload broadband data (transaction/load) algorithm to add data, process and put into existing data
  - Can also be applied to other data formats
- Working on mobile application also

- Looking to rewrite this from Silverlight to something more accessible to all mobile devices

- Trying to build a database of historic imagery
- Survey sent out through MSGIC email list
  - About 100 responses were received
- Committee sent out letter to various agencies (received 120 responses in total now)
- Trying to build a database where images are available
- Build a database for those doing research in Maryland (archaeological MEPA requirements what was there, anything of significance for building in an area)
  - Most of the data has come from AA County to date
  - Searchable database
  - Potential to download digital images directly in the future

  - Want to do a study of coordinating systems that are in close proximity with each other, but are unique and unconnected systems
    - Ride Guide (WMATA) has put some of this together
- Recertification Review as Organization
  - GIS will support environmental justice (application is requested)
    - Shows data crunched and one that does analysis inside of application
    - EPA might have an example which is out there now (shows toxic sites, with buffer areas)
  - o Initially for the Baltimore Metro Region
- TUgis before Ice Cream Social (Emergency Preparedness for GIS Professional)
- FEMA Region 3 Risk Group meet quarterly w/GIS subcommittee
  - o Discussing FEMA exercise concerning hurricane in Silver Spring
  - o 200 people participating with 25 agencies

- Intent is to find holes and discovered things that are going to break to try and use these results to prepare for actual disaster
- Talked about organizing calendar of events of when these exercises are being conducted with GIS components to get others involved in participating or watching
- Expected to be conducted in the beginning of April 2012

  - Disaster charter for hurricane response
  - How they used Remote Sensing in Joplin tornado and determine the level of effort needed to support those impacted by the event
