- Washington College has pulled out of the conference completely

**Response:** Open to adding this back in

• Putting together a video concerning the GIS community and getting some folks to speak on the video

**Question:** What is the goal for the number of paper presentations?

**Response:** Around 24, 3 concurrent sessions with 3 presentations per session

- MSGIC Quarterly and CMUG meeting are next week at which time we can market the need for more presentations
  - o Potentially push back the abstract due date a little bit further
- Barney Krucoff going to Washington College next week and open to having a discussion with them concerning why they pulled out of the conference and encourage them to get back involved
- Volunteers parameters has been agreed upon
  - $\circ$  Students deadline to get their materials in to be selected as volunteers set for 2-3 weeks after semester begins
  - Website is being adjusted to add this application information
- Issues concerning mailings delivery have been resolved with the most recent test getting a 98% delivery rate
  - o Some had been getting hit by spam filters, but change got the email through to people's inboxes

### Federal Activities-Roger Barlow

Strategic Direction for hydrography

- NHD training was hosted for select trainees on Dec 13 14, 2012
  - o Included NRCS, State of DE, Washington, DC reps
- NHD current edit tools for 9.3.1, 10.0 tools to be released shortly and no tools for 10.1 platform to date
- MDE direction with USGS is not to take what's out there and make corrections or modifications
  - Looking to take local data, those who are willing to share, run through USGS conflation tools and migrate that into NHD 2,400 scale
  - o Didn't cover conflation tools during training, but can setup a Webex for training if that's the direction people want to go in
- WBD watershed group representative Kimberly Jones has indicated that watershed errors and coding in Western MD is in the process of being corrected
  - State watershed coding doesn't match NHD or WBD
    - Take watershed to them and migrate to WBD and use 16 digit coding
    - Migrate directly to Federal government coding system

- o Issues of getting people to change from state watershed codes to federal watershed codes
- o Sizing of the watersheds would be avoided by taking this approach
- Look at local stream data, Patapsco, Baltimore County and do some tests on conflating to NHD standards, get posted and if goes well expand the process
- To be completed within the year
- To have local agencies, regional agencies, state agencies and federal agencies needs met in one dataset is a plus and what is being worked toward

**Question:** Have many local governments already shared their data with NHD?

**Response:** Anyone who wants to do their own conflations, this works and this completed information can be sent directly to Federal government

**Question:** Can interns be used to assist in the process?

**Response:** Need to determine the order of the watersheds that are going to be completed before interns can be assigned

- MDE is the steward for NHD and relying on them for coordination including proposals and grant funding in the next fiscal year
- Request suggestions for priority watersheds that should be done can be solicited from the group
  - o Contact Frank Siano or Roger Barlow with these suggestions
- NRCS has expressed interest to work with MDE concerning watershed boundaries
- Discussed using the LiDAR to regenerate the watershed boundaries

### Prince George's County photogrammetric project

- Meeting set up for 1/22/13 with Park and Planning Office representatives (Dale Hutchinson and others)
- Trying to get this data into the public domain
- Updates from this effort to be provided in the future
- Before meeting might ask for bullet list of USGS initiatives which have been funded in Prince George's and Montgomery County areas, to assist with making the case

### FGDC CAP Grants – Program Announcement Pending

- Due to financial changes in the federal government, funding is currently on hold
- No open or close date at this point
- Stay tuned as the financial issues are resolved

# NAIP 2013 (?)

- Agricultural Image Program
  - o Collections this summer at height of growing season
  - o Collection same parameters as 3 years ago 1m statewide, leaf on
  - No state buy-up option at this point
  - o Timing and access to the data, takes about 3 or 4 months to get composites of the data
  - o Gretta Luedeke will have data and will be willing to distribute it

- o Future cycles vary concerning recollection of the imagery, expect to see 3 year cycle for the foreseeable future
- Request that Gretta Luedeke make an announcement concerning this information at the Quarterly meeting in January 2013

# Coastline Shoreline Meeting Organization

- 2,400 scale shoreline/coastline desired
- Collected a list of people and contact information
  - Looking to start reaching out next week
- Derive from terrestrial tide coordinated LiDAR and bathymetric data
- Tidally reference based on b-data
- Has been done successfully in NJ, has been documented and accepted by Federal Government
- Federally accepted, uniform shoreline at large scale for long-term and short-term inundation modeling and other shoreline studies

### Other Activities

- DC Ortho imagery tentatively to be flown this Spring
  - o Funding problems still exist as of an update from yesterday
  - o Have funding, but have to make sure they are allowed to spend it on this particular project
- LiDAR collection is needed for Queen Anne's County
  - o Funding ideas are welcome, please provide them to Megan DelGaudio (mdelgaudio@qac.org)

#### Other Activities

- Memo from Chief of Staff has been received concerning Situational Awareness
- Want to assemble a Situational Awareness Committee
  - o Barney Krucoff is the coordinator of this group
  - o First meeting January 24, 2013 to invite various agencies to participate
  - Emergency management and law enforcement type data focus
  - o Overlaps with GIS, but not strictly GIS
  - More focus on real-time and sensitive data then we typical cover in our meetings, but many of the issues are the same
  - Promised that UASIs will be invited, start small and inside the state
     (Technology Committee Chair Patrick Nowlan would be a good contact, Cal Bowman is another good contact person as Executive Committee Chair)
  - o Meeting will be open to any who wish to participate
  - o Relatively new effort and questions can be sent to Barney Krucoff for clarification

  an overview of what the position means and how this person might be going out to meet people throughout
  the state

  - o Contact Barney Krucoff, Kenny Miller or Russell Provost to get onto Russell's tour
- Focus at the next Numbers Board meeting
  - Collect addresses at local level to supplement the statewide addresses we already have
  - Let them know what we want to do with the data and want PSAPs as suppliers of this data
  - Show them the advantage of having data from the surrounding counties
  - Might mention the Situational Awareness memo with the group, but not a requirement to participate, more for information sharing

Review of West Virginia GIS Associated Dues and Annual Report

- Started non-profit GIS organization in 2006/2007
- Current dues structure is significantly lower than what we are proposing
- Annual Report includes:
  - Where members are coming from
  - Membership totals
  - o Executive Board information concerning members of the Board
  - o Reports from members of the Executive Board
  - o Growth of membership
  - o Information budget/income and break outs for income and expenses
- Anticipate that MD should be in a similar or better position concerning collection of revenues
- Question would be why the membership trends up at a certain point and ask what efforts they put forth to get those numbers to go up
- Suggest a conference call with this group to ask what their methods were and lessons learned they are willing to share

Local Government Updates – Shawn Wampler

 Working on updating website contact list and reaching out to jurisdictions to get more participation with MSGIC

Baltimore Metropolitan Council - Sandi Stroud

- Data project meeting next week concerning the completion of the centerline and address point data
- February 2013 meeting with Russell Provost concerning the address project
- Report from Baltimore UASI meeting to be sent to participants in the near future
  - o Gaps identified concerning public safety and technology were governance and regional coordination
  - o Recommended a CIO group creation
    - Start regionally and look at technology projects on-going and emerging technologies
  - o Might be a group that MSGIC would want to do outreach with
  - Looking to branch out beyond public safety

Eastern Shore (Mid-Shore & Tri County Council) – Lauren McDermott

- MACO / Ortho kickoff meeting January 2, 2013
  - o 7 of 9 Eastern Shore counties represented and 3 emergency managers good turnout

- o Counties need more real-time data particularly concerning power outages
  - 4 hour intervals was not often enough
- o Counties hindrance during an emergency is that they often only have 1 GIS person which makes it difficult to take advantage of all GIS resources from the State
- Training discussed concerning other potential users who aren't GIS people, but could be additional resources during an emergency
  - Discussion with deploying a ESRGC member to the EOC of a local county during an emergency to provide assistance in response
  - ESRGC working to be more proactive about making these resources known and available
  - Training can discuss what can be done on their own and more can be outlined on what they need to do to request enhanced help
    - Funding will have to be taken into consideration
  - Clarification will be needed on what resources are available, what each offers, what each entails and which are secure versus public, etc.
- Road closure data was of interest
  - Working with Frederick County to start getting this supported
  - A web application to be used during an emergency
- o High volume of emails during an emergency
  - Might suggest a pre-determined subject line, so they are easily keyed into those which are resources coming from the State
- o A statewide call was also suggested
  - Need to clarify how often these calls should occur
- Aerial imagery was discussed
  - URS talked about web tool which would be available to the counties to flag errors
  - ESRGC will be available to assist counties who don't have the resources to go through their own imagery review
- o Putting together a better email list concerning the emergency managers throughout the Eastern Shore
- O Definition of low-lying areas needs to be clarified, especially when there are mandatory or volunteer evacuations and making sure everyone is using the same definition

- Unveiled Regional Transportation Clearinghouse web mapping, Adobe Flex application
  - Showcases data which is available from the participating organizations
    - Traffic counts, transit ridership stats, population and unemployment projections to 2040
  - o Available to members and local governments, password protected
  - o Password can be obtained from Charlene Howard, if interested
- GDX training is on February 5<sup>th</sup> details can be obtained from Charlene Howard

### MD iMap Technical Committee – Julia Fischer

- Cascading Geocoder
  - o Meeting yesterday to discussion the components which would be included in the geocoder
  - Originally discussed having two geocoders
    - One would cover the address geocoding
    - One would cover the place name or keyword geocoding
  - o Decided to have one geocoder which will include ten unique components
  - o CGIS now in the process of tracking down and obtaining data needed for the components
  - Discussions have also occurred about making each of the geocoder components separate, so they can be consumed singularly or as a whole
  - o Additional details will be provided to the group as they become available
- Service Pack Implementation SP3 to SP5
  - $\circ$  Scheduled to occur throughout the week with 2 hours of downtime on Friday 1/18/13 from 6 8p.m.
- Map Service Data Review
  - o In the process of reviewing the data and map services which are currently in the MD iMap system
