Implementation Plan

- Discuss dues implementation summary document
  - o Worked to get as many of the names identified from the database and find out contact information
    - Very thorough job was done
    - No longer need a letter campaign concerning those who only had addresses
  - o 860 members have been verified, there will be a few that will be dropped for lack of information
  - o This will form our distribution list for newsletters, etc.
  - o A sub-set will become dues paying members who will receive additional information via email
- PayPal all set up to collect payments and filter them to the Columbia Bank account
- Revised the application form, changed the sponsorship form a little bit allowing for tiered levels
- Conference call recently to go through the key questions concerning implementation of structure
- "Policy Recommendations for Implementation of Membership Dues Structure" went out yesterday
  - o Comments or questions?
    - Bottom box: "Need to provide..." section should be defined internally first and to all members later
  - o Last 2 boxes are things we needed to do to start planning
  - o Key points: be inclusive and allow all to attend Quarterly meetings
  - o Only members can vote
  - o Be as liberal as possible concerning students and who is a student
    - Anyone registered for a class, even if they have a job
  - o Paying people or organizations defined
  - o July 1st official start date, but now is really the official start date

- o People will have until January 2014 to pay their dues and will not have their classification changed until after the Spring Quarterly
- o Allowing for 1 year to come up with the dues payments
- o Not going to get into partial payments/installments too complicated at this point
- Doug Reedy to provide report as Treasurer for each Executive Committee meeting and report a brief report at the Quarterly meeting and an annual report for publishing
  - Expenditures: \$40 for files
  - Balance: \$2,481
  - PayPal account setup
  - State tax document has been received by Chris Slavin and will be filed shortly
- o Hoping to get a few more sponsor organizations in the next few months and would like to see a few counties and local governments go with one of the tiers, get this process started
- o DoIT, MDP and ESRGC are signed up as corporate sponsors

**Question:** Has there been recognition by State Government for input or provider of information to the State?

- o Links to the website to MSGIC and vice versa, DoIT is a sponsor of the organization
- o Role and recognition of MD iMap and MSGIC by the State of Maryland
- Would like to get MSGIC's website off of DNR's web server, so we can differentiate the two sites and get sponsor banners onto the MSGIC website
- o Want to minimize duplicative web content on the MSGIC and MD iMap websites
- o Content on each website describing the other, but the two websites have different uses
- MD iMap Executive Committee meeting held last week and received feedback concerning updates that need to be made to the MD iMap Portal website
- Governor signing off on the renewed MD iMap Executive Order, lists MSGIC as a participating organization

**Question:** Short of an official statement from the Governor is a contributing organization or MSGIC subservient to MD iMap?

- o Affiliated, but independent
- MSGIC is more cross-sector
- o MD iMap is more state-focused, including funding which goes to improve any entities

**Question**: How should the response to the question be messaged out?

- At quarterly meeting provide update on timing and roll out and point out that some issues were brought to the Executive Committee's attention and were addressed
- Could setup an FAQ on the website and drop the last 2 boxes, which are about the organization as a whole and not this particular issue

**Question**: Is this something for the newsletter?

• It would be a very good idea to include this information in this upcoming newsletter

#### GIO Briefing – Barney Krucoff

#### New Hire

- Matthew Sokol is from Spatial Systems, Inc.
- Started a few weeks ago
- Works with law enforcement and will be working closely with MCAC and Fusion Center
- Three tasks:
  - o Flow of data on suspicious activity (secure/protected)
  - o Maps of critical infrastructure
    - Pulling together critical infrastructure types of locations, what sector is it in, build up at MCAC and share with the rest of the community
  - Crime data
    - There is lots around, coming from the local governments to the State, but there is thought to be a lag in sharing, working on data flow improvements and opening up communication
    - o Spoken with some Governor's Office reps very interested in crime mapping, data being submitted, but not to the state, work on a county level to get data, get other violent crime data (type 2)
    - Some data for analysis and discussion about what level of data should be made public, scrubbing to provide data out, but protect sensitive aspects of the data
- Working to get in touch with the right people, getting data mapped, combined and out to the contributors
- burgersub.org is a student website which chronicles homicides and other violent crime data
- crimereports.com is a place where counties have been publishing their data for a significant length of time
- Other part of the job is liaisoning with GIS professionals in the Eastern Region of the State
  - Anticipate sometimes proactively participating at functions where groups are active

#### MD iMap Executive Committee Update

- Next meeting scheduled for June 26<sup>th</sup>
- Open discussion went well, did not learn a lot new, but reemphasized existing priorities
- Data needs to be available in more formats
- The way we currently make the data available is not as useful as it could be
- Reminders that we need to move along faster
- MD iMap Portal website concerning where to go for information needs to be restructured to make data easier to find
- Showing developments that we have been working on and will see these at TUgis
  - o Application template
  - o Data multi-purposing, etc.
- More conversation going on this time then last time, much better meeting
- Good for everyone else to hear that there were unity in the room about where to go
- Idea that many people do not have feedback at all, which is often natural, points out that these are the people paying for it, but are not using it
- Conversation about the ELA and what we need to do to get State organizations onto the State License Manager

- Making a case for moving forward
- o This was a good discussion and what the Executive Committee should be taking up
- o Will be a regular feature moving into the future
- Showed improved tracking of data
- o Showed we need to get more people using the license manager to get more accurate results from it
- o Also showing the ArcGIS Online statistics and this will be shared regularly on the Portal
- Good to let people know that the utilization of the ELA is being tracked
- AXIS GeoSpatial, LLC liked what was heard and was encouraged about the involvement
- Can be frustrating about how little people know and are involved, but we are still at the education and awareness phase and this meeting was a good forum and promotion
- Suggestion for moving forward
  - o More on accomplishments from different groups or agencies
  - o More technical focus was on what is in progress rather than what has been completed
- Attendance was phenomenal, public private, local, State cross-sector
- Question arose about who is MD iMap's targeted audience GIS professionals or general public?
  - o Made us think more about this again
  - MD iMap Portal website is for GIS people, public, but do not want people coming to Portal to find out about Septic Policy, should be at MDP or MDE to get this information
  - o This is the Portal for GIS users and we will make that our audience, whether in the State or not
  - o Not trying to duplicate the basemaps and other resources that Google or Bing provide

## Cascading Geocoder

- Expected to go live shortly
- Will include some additional webpages to the MD iMap Portal
- Local address points is first rung, MDPV is the second rung, Street Centerlines, etc...
  - o Exit ramps, mile markers, place names are other geocoding layers
  - Ties to addressing data being collected by Russell Provost
    - He will be collecting the first tier data through his addressing efforts
  - o No charge for using this resources and Maryland centric
  - Geocoder comes back with what database you hit and can limit the geocoders that will be hit within the full cascading geocoder
- ArcGIS Online improvements to geocoder to be released in the near future
  - Need to look into specifics from Anthony Puzzo
- Do not need to wait to add the local address before this resource is released
  - o Will add that data in later version and improve the results from this resource
- Esri will be cutting off access to their geocoding services without going through ArcGIS Online in the near future, this requires that the service be paid for
  - This might result in everyone going back to having their own individual geocoders
  - o ELA for ESRGC gets StreetMap dataset which is what the Esri geocoder is made from
    - ESRGC is planning to include this resource into their geocoder on their local servers, as a solution for the need to nationally geocode
  - o Will ask Esri if this is something that can be shared on their public servers for others to use

 Costs attributed to providing and maintaining a geocoder with this released data, which is being offset from Esri to the locals if they choose to create a unique geocoder with the provided data

## **Local and Regional GIS Coordination Efforts**

Local Government Updates – Shawn Wampler No updates at this time

Baltimore Metropolitan Council – *Sandi Stroud No updates at this time* 

Eastern Shore (Mid-Shore & Tri-County Council) – Lauren McDermott

- February 20<sup>th</sup> Mid-Shore GIS meeting in Easton, MD was well attended
- Watershed implementation plan was a good topic of discussion
- Land use maps vs. impervious surface utilization was discussed in depth
- Most of the jurisdictions are moving to 10.1 and have discussed loss of resources
- Joint meeting between Lower and Mid-Shore scheduled for April 24<sup>th</sup> at Salisbury University
- Need to fill out a matrix more concerning the resources counties have related to impervious surfaces
- Need to address the Numbers Board about getting roads and buildings updated
  - Central counties are moving at a much faster pace of updating, where outlier counties are not updating very often or at all
  - o Dollar estimates have gone down since the original data was created

Question: Are Standards available? – Data models are available

- Work in Somerset County on parcel data, roads leading to accounts which are not private easements and are not included in the data
- Many counties have not updated in a long time, they might feel that the entire process needs to be redone, which has higher costs and requirements
- Opening session of TUgis is designed to get some of these topics out in a room that contains GIS professionals from all of the local governments throughout Maryland
- Think about collecting footprints from LiDAR rather than imagery
  - o How can we make this as multi-purpose as possible for requesting funding from Numbers Board
- Discussion about GIS data as an asset for running a local government
  - o Usually understood by the technically minded, who are not those in decision-making positions
  - From multiple perspectives of running local government, GIS data is a key asset, do not want this
    information that is being relied on to be out-of-date
  - Need to share this same message with all of the different groups, from all directions, from top down, as well as, bottom up

MWCoG – Charlene Howard No updates at this time

Central Maryland Users Group (CMUG) - Jamie Alvarez

• May 17<sup>th</sup> tentative date for next meeting

- Still trying to lock this date down
- If not merged with GIS in Business (GBiz) Conference, it will be moved to a date in June instead, since there is an abundance of meetings around this same time in May
- A few presentations are already lined up:
  - GeoPDF projects
  - Datastory Consulting
  - o Sorting out technical demo from Esri
- Locked down the location once the combination of the conferences is confirmed
- Either at CCBC Catonsville or Howard Community College
- Agency item about Maryland update to be presented by Julia Fischer

## Western Maryland User Group & Tri-County Council – Debbie Carpenter

- On-going issue about boundary line between Allegany and Garrett Counties
- Finally received from SHA the Chisholm line is now the accepted line

**Action Item:** MD iMap needs to verify that the county boundary reflects the Chisholm line

o Census uses, MDP uses, both counties use, but not all State agencies were using the Chisholm line

#### **State GIS Coordination Efforts**

MD iMap Technical Committee – *Julia Fischer* 

- Map Service Consolidation
  - Map services have been turned off or removed to begin the clean-up/consolidation process and allow for hosting a few new map services
  - o Recently received information from Esri that we might be managing 10 times as many map services as they recommend
- Application Template Update
  - o Template released with the FY14 Capital Budget map
  - Setting up meetings in the upcoming weeks to get some of the many existing non ArcGIS Online apps moved over
- MD iMap Portal Updates
  - o Links have been added to the homepage for the MD ELA and new K-12 Education ELA homepages
  - o A link has also been added to the Developers tab for the GitHub account for the application template

### Orthos/Parcels/Septic Tier Mapping – *Jim Cannistra*

- Orthos
  - $\circ$  Imagery collection has been proceeding well with about 81 82% complete at this time
  - o Some turbulence and flight clearance issues down near PAX
  - o Only a couple more days' worth of flying left
- Parcels
  - o Finishing counties on the Eastern Shore and getting ready for new ones to do next year
  - Somerset County to be completed in the next few weeks

- Worcester and Wicomico Counties getting started for next year
- Septic Tier Mapping
  - o Progressing as working with the counties
  - Applications exist that are for status tracking
  - o Want to put together application to show septic tiers within each county

#### Broadband Availability – Mike Scott

- Discussions have begun about what will happen to this project after April 2014
- Conversations at DBED to find out to what degree the information has been useful
- No centralized move to encourage broadband development throughout the State, especially in rural areas, but also in pockets within the central regions
  - o Issues with getting fiber to the home still linger
- Conclusions being drawn to either wrap up existing efforts or continue on in a reduced fashion
- Community Anchor Institutions schools, libraries, non-profit centers
  - A lot of energy has gone into this layer and want to see where it will land based on all of the errors that have been brought together
  - o Need to publish and make this a marketable resource for future use
  - Date for publishing CAI data, even if published without complete broadband connectivity data TBD, but near future

## Chesapeake Bay Critical Area – Mike Scott

- Application went live recently, supports multiple counties searching
- About to start public meetings in Caroline County
- Anne Arundel County delivered to county on Monday to start review process
- Map showing what phase each counties is in in the process

#### dFIRM Conversion - Mike Scott

- Talbot County just got new dFIRMs
- Some of the Eastern Shore counties are actively working on getting dFIRMs
- Reducing flood heights in the Upper Chesapeake Bay is shrinking the amount of land in the 100 year flood plain in that area
  - Causing concern that there is something amiss with the modeling, which is reducing these flood heights so significantly
  - o Those living in these areas are concerned that the numbers are not right
  - o Grandfathering provision, allowing people to buy insurance at the old rate, for a fixed period of time
- Digital dFIRMs are available for download

TMDL Effort – *Dept. of Environment No updates at this time* 

Outreach – Jen Chadwick-Moore No updates at this time

#### MSGIC Coordination – Data Resources Subcommittee – Patrick Callahan

- Discussion about internal Portal for State and counties to share services and to point back to County sites
- Listing this on the MD iMap Portal with links to the Counties
- MSGIC made a recent effort to provide website links and contact information for State and Local agencies
  - o Currently working on Colleges & Universities
- MD iMap site has services listed and will continue to expand this list, but heard before about data downloads, this is available on the MSGIC website, but out-of-date
  - Working to update with organization name and webpage link
  - o What is a data download page? Data download site or place where you can get .pdfs, etc.
    - Miscellaneous maps hosted on a website would not fall into this category
- Consider rewrapping the data from MSGIC website, do not want to duplicate it
- Also facilitate a place where the State can get County data, some way to share back up to the State agencies
  - o Same idea as the GDX
  - Need one solution for protected data and message out this singular location from multiple locations
- Assessment of the jurisdiction capabilities
  - o Need assistance with standing up data, map services, etc.
  - What are capabilities of local areas to complete GIS-related resources, but do not have capability or knowledge to take it to the next level
- Common Symbology
  - o Coming up with streamlining to a Federal standard
  - o Making it consistent at State and County levels and even between counties
  - o Allow for new services to be resymbolized at version 10.1
- Maryland-National Capital Park and Planning Commission
  - o Met with them and no resolution was reached
  - Awarded their contract to Kucera
  - o Made a strong case to share imagery and LiDAR
  - o M-NCPPC would re-evaluate policy of sharing the outputs of this contract
  - o Jim Cannistra working to put something together in writing to make this request formal
  - Based on policy that the GIS group put forward and was not officially adopted, but moving forward using it until another policy is brought forth
    - Going to have to assist them with moving the process along by putting a memo together and presenting it to get the standards of sharing changed at their level
  - Continuing to pursue this topic
  - o Significant interests in Montgomery and Prince George's Counties LiDAR updates at the Federal level
  - Montgomery County, Rockville and Gaithersburg Planning meeting coming up in the future and Jim Cannistra and Barney Krucoff to attend

# Federal Coordination Efforts - Roger Barlow

LiDAR – new (fall) acquisitions

- Calvert County still in the process of evaluating the LiDAR concerning tiles missing
  - o DEM will go into National Elevation Dataset once these are found
- Carroll County was entered in the National Elevation Dataset in February 2013
- Frederick County has been accepted and delivered to USGS as part of a larger delivery
  - Hard drive to be delivered today to download Frederick County data and provide to Doug Reedy, Nature Conservancy, and ESRGC
  - o Three-fourths of Carroll County was funded by NRCS and one-quarter by FEMA
- Hurricane Sandy LiDAR continues to change, Dorchester and Talbot Counties 1/27<sup>th</sup> arc-second data to be collected in these counties in the near future, because of Blackwater Refuge
- Not totally sure how these areas are going to be weighted and ultimately decided to be or not to be collected
- Know USGS to get \$6.4 million for collection which will come in two pieces in the future
  - o Asked for more, but got what was expected
- \$14 million for total impact area, asking for matching money and those areas that provide matching money will move to the top of the list
- Collection anticipated for December 2013
- Interest email concerning Shoreline working group was sent out
- Meeting scheduled for April 2013
- Chesapeake Bay Sentinel sites NOAA program
  - o LiDAR is important and derivative products discussed and they are included in this group
- DC OCTO & DC Department of Environment concerning MOU
- DC just advertised their photography, expecting it to be re-flown
- Flood mapping (multi-agency) meeting in January
- Federal monitoring graphic, stations will be depicted on graphic, which will be shared with this group
- Helps to decide where flood mitigation will occur
- Urban Waters Workshop
  - o Patapsco and Anacostia combination of green space, land use, impervious surface
  - o Getting people access to this data, some agencies are funded for this and some are not
  - o Pulling this together about geospatial coverages and depictions
- US Topo new application came out few weeks ago to convert from Topo to GIS usable versions
- Information below from Stephen Aichele (USGS)

"Attached below is a GlobalMapper script and shapefile to convert USTopos from GeoPDF to GeoTif. The script requires GM13.1 or higher to work. The shapefile is required to clip the collars from the quads. Instructions are included in the script.

There has been considerable demand for this functionality since the introduction of the USTopo, and this script is intended to meet the needs of users who require the quads specifically in a GIS - for creating publication documents, for overlaying their own information on maps for field use, etc. In the future this need will likely be met by Data Packets for each quad, containing the vector data and symbolization necessary to recreate the quad in ArcMap. However, Data Packets will not be available nationwide until the next cycle of USTopos are produced. This script is intended to largely fill that need in the interim.

We would like to avoid having users broadly replicate the USTopo offerings or create duplicate map services displaying the USTopo content. The tiled basemap cache that Rob Dollison demo'd a couple months ago is up and functioning well. The cache can be added as a service in ArcGIS by adding the ArcGIS server <a href="http://basemap.nationalmap.gov/ArcGIS/rest/service">http://basemap.nationalmap.gov/ArcGIS/rest/service</a> and selecting the USGSTopo service. If you have trouble with it talk to me or Rob and we'll try to walk you through it.

The content in the tiles will be fresher, and many more features are labeled than in the USTopo. If users desire a continuous topographic map service as a backdrop to an application, they should use the basemap cache rather than convert the USTopos and create a parallel service. If they need a quad (or several quads) for field work or as a publication base, feel free to share the script at your discretion, but be sure the users are aware of the service and the benefits of the service."
