Question: M. Scott, would you feel comfortable talking about the intern contract? Yes.

- Contract Indicated that there is a 10% indirect cost.
- Clocked in 184 1/2hrs (Jan 9<sup>th</sup>) from July 1 till now.
- There is a 10% indirect cost that Salisbury adds to each contract.
- They pay there interns \$12/hr although we advertised the position at \$10.
- o Do we want to hold at \$10 or go with the standard rate from Salisbury?
- A miscommunication on our (Salisbury's part) to what the intern would be paid.
- o ESRGC would eat the difference if it was really \$10 we wanted.
- o It would be complicated reverting to \$10 as she has been being paid \$12.
- Cost between July 10 Dec 10) she was paid\$ 2,245.40 184.5 at \$12/hr + 10% indirect.
- Annual not to exceed \$5K we are very much at that level staying currently at 12 but not to exceed 5K
- She has been doing a great job and if we are staying under the 5K think we should stick with that.
- Vote: To officially change the intern rate from the advertised rate

# GIO Briefing - Barney Krucoff

- Russell Provost has been recruited by Michael Baker
  - His last day at ESRGC is Jan 30<sup>th</sup>
  - Working with M. Scott to fill position so may be looking to merge with some of that work being done on the Centerline.
  - o Local Government dedicated Liaison potentially.
- Council Open Data Report now live
  - o Annual report and legislative requirement
  - Several recommendations
    - Not a full repeal but a retraction on ability of agencies and local governments to sell their data and elimination of requirement that they enter contracts when they distribute.
    - Liberalization of their ability to provide it online.
  - o Hope MSGIC will support as well.
  - Sen Ferguson who is on the committee is either going to put forward either what we put forward as a committee or something very close.
  - o The Governor elect put forward someone to look at Charter schools.
  - Checked and we do not have anything just showing those.
  - So need to be aware of the issues that are emerging and should bring to the attention of DoIT and MDiMAP.
  - Holding pattern waiting to find out who will be in charge.
  - o iMAP 1.0 was shut down and has gone fairly well but have had some issues.
  - o Image service is really popular but running into problems.
    - o Think the service has been resolved but not everyone is consuming them the same way.

- Had some performance issues and had made some changes to the servers and those fixes seems to be working.
- Do not think those changes should have been necessary so having ESRI come in toe review.
- Selected WBCM to start their training program.
- Developing courses for their folks to learn how to work with iMAP data, ArcGIS Online and Desktop.

Maryland elevation, land cover, aerial imagery, and county-level socioeconomic data, provided by various trusted sources, are available through the Digital Coast's Data Access Viewer. Some of the most commonly accessed Maryland-based data are highlighted below.

Coastal LiDAR

Over 371 gigabytes of high-resolution elevation data covering Maryland's entire coastal zone are available. This type of data is critical to the development of models that examine potential local flooding impacts from coastal storms and sea level rise.

## Land Cover

Land cover data provide inventories of coastal intertidal areas, wetlands, and adjacent uplands for the coastal regions. These data are used to identify high-priority landscapes for Maryland's coastal protection and restoration efforts. Economics: National Ocean Watch

Managers in Maryland use this tool to help stakeholders visualize the effects of sea level rise.

# GEOSPATIAL CONTRACTING

Through the Digital Coast, coastal organizations in need of geospatial data or services benefit from the use of the NOAA Office for Coastal Management's Coastal Geospatial Services Contract. This contracting vehicle provides a way for local, state, and federal agencies to take advantage of a streamlined process to obtain services from the nation's top geospatial firms. In fiscal year 2014, over \$1 million was awarded to private geospatial firms to conduct mapping projects in Maryland's coastal zone, including the acquisition of imagery data.
