 - Julia Attended recently; There are 2 meetings every year (annual and mid-year);
 MD is unique that we are enterprised and embedded in IT
 - Julia Wants to setup Statewide LiDAR collection Program and put in for funding for program. This should be a partnership with Universities, Locals, Regional, etc.
 - NG 911
 - Julia Funding available through 911.gov Grant program 115 million; Specifically for PSAPs, but consultants can get some funding for limited applications
 - Pat C. Only local? Not State
 - Julia Not Sure
 - Al Can numbers board go after the funding?
 - Julia More research need to be done
 - Al If you accept numbers board money, you cannot go after 911.gov money, can be done subsequently, but not at the same time
 - Julia 911.gov funding pays for "butts in seats" for duration of grant
 - Julia New Legslation HB 1062; Changes in how taxes go; Seeks to create another group (similar to PSAP) to establish policy / goverance at the PSAP level; Emergency Managers have group through MaCo
 - Marshal GIS representative for Numbers Board?
 - Julia Informal nod, but not sworn in

- Marshal any more discussion about move from County-led to Regionalled structure? How are we going to access it?
- Pat C. Cross-county conflicts / coordinations (PSAP boundary overlaps)
- Mara Counties begging for guidance above
- Marshal Coordinate funding distribution
- AI Frederick County is administering State-wide vehicle (Mission Critical Partners); Still working out how funding will work; MCP – test database against standard and then come back and test
- Julia MCP picked (not created) standards; Question comes up are these the standards? (need top down directive); County Buy-in not in place
- General Discussion Not open competition / open talk; Concern that the company from out of State (Northrop Grumman)
- Pat C. Still need answers on how to upload and pull down data
- Julia Why was the standard picked?
- Mara Counties assume that at some point State will come in and declare a standard; In the absence of declared standard from the State, counties are going with what is available. Concer from county is that Bill (SB 466) declares that there will be punitive measures for those that don't comply, so counties must get something implemented, even knowing that the standards may change.
- Julia New Secretary CIO announced shortly; He knows GIS and could be champion; NEMA standards been in draft for 15 years; Julia to reach out to Pat C. / Peter to continue coordination
- Julie Surveyers Community... Legislation proposed in different states to change sign-off authority, etc. that impact GIS. Virginia is greatest concern due to parallels in surveyor leadership, geographic proximity, and they have recently submitted legislation that could impact MD GIS. Something to keep an eye on
 - Mapping Board keeping an eye on it
 - Michael Scott Is there any hearings scheduled in Office of Chamber?
 Should we be worried? Look at Bill for American Heritage Areas; Good bill
 - Julia James Samuel Coleman Act of 2017 Puts school boundaries into the hands of Dept of Planning / MD Department of Education
 - Mara MD House posting 20-30 bills a week
 - Pat M. Different members of MSGIC / other groups have identified different bills based on separate reviews; A lot to go through.
 - Julia Opportunity to post up consolidate list of Bills that could affect on MSGIC website while identifying signs / flags that the bill may not be a serious concern, such as no opposing bills and no scheduled hearings.
 - Michael Communicate information to members so they understand the legisliative process
 - Julia Leverage Advocacy Chair
 - Pat C. Include disclaimer that just because a bill is list does not represent an implicit / explicit endorsement or opposition to the bill
 - Pat M. Highlight those bills that are important / may require action
 - Ashley Will add table put together by Pat M. on website

- Education Julia Fischer
 - Art Lembo's Open Source Training for TUgis; There is Clearly interest in open source GIS / training opportunities.
 - Julia recommended creating a series to be offered by MSGIC, including courses in Python, Spatial SQL, PostgreSQL, etc. Art suggested around \$200 per course (8 hours) with ~10-15 in classroom; Need to decide how to distribute cost – will Members pay and / or will MSGIC absorb some of the cost?
 - Erick Members footing more of the cost make them invested in coming to training; Need to find potential locations
 - Julia Coordinate with URISA for Test Prep Course; URISA NG911 course cost \$1000;
 Schedule more LiDAR training

 - Michael Also Salisbury
 - Julia Art recommended talking to other Universities as well, including Frostburg, Bowie State, and St Marys

 - Ashely running into issue with migration that she is not owner of domain; Coordinating to get ownership transferred to Dr Scott
 - Pat M. Sid has submitted Non-Profit Packet for Esri Non-Profit AGOL account; Sid went through Anthony Puzzo, timeline TBD.
 - $\circ~$ Erick Looking at other GIS organization website, not a lot of maps or interactivity
 - Ashley Shooting for TUgis for migration release, but TBD due to road blocks

 - Sid not present, Dawn has no updates
