- Pat M. Last meeting was left as Julia / Art need to get together and finalize details. Training should be topic for the survey
- Patrick C. Revive Michael Scott's LIDaR training. Are there other non-program specific training / seminars we can sponsor?
- Peter What about Esri Arc Pro?
  - o Julie We piggy back on the state to keep costs down
  - o Niki Are those classes open to state employees first, and then others later?
    - Pat M. We have previously sponsored the training to open it up to larger audience
- 2018 ArcGIS Online Competition for MD for Middle and High School Students Patrick Callahan
  - Patrick C. National Geographic has pulled funding for many local initiatives. Maryland Geographic Alliance will be dissolving. Virginia Thompson asked about having MSGIC support / sponsor the 2018 ArcGIS Online Competition for MD for Middle and High School Students. There is a grace period, but the deadline is Jan 12th. Should we just wait until next year?

    - Pat M. MGA had a framework / steering committee with 1 FTE, but there was not
    - Julie Do we have the names for the org?

      - Pat M. Maybe put out a call for rep to come to the Feb Exec meeting
- TuGIS Advisory Meeting Patrick Callahan, Julia Fischer, and Pat McLoughlin
- Strategic Goals 2017 Pat McLoughlin
  - Pat M. Unless we have something specific to bring up, they should be removed from the EC agenda
  - o Patrick C. Will talk through them at the quarterly
- Working Groups
  - o NG911/Public Safety Working Group Peter Hanna
    - Peter Scheduled bi-monthly meeting on 9th Feb. Sent out email to Mission Critical and was told that the numbers board will be updated on the first week of Feb and jurisdictions will be told shortly after. Will have an update for the Feb Executive Meeting. Call for as many GIS professionals to the meeting to show our support, let Peter know so that he can get them a heads up. Looked at the data models for Mission Critical and NEMA, they are very similar. NEMA model was

better due to shorter field names and that will be the one they will be recommended. He has a spreadsheet that compares the 2 models and will put it up to Google Drive. The things that scare users about the NEMA model is that it is still draft and hasn't been updated by 2013. NEMA model adds in railroad, hyrdology, router locations, etc. Prepares for future use, but has what is needed right now.

  - Pat M. No change, still needs to be presented to the Numbers Board
- o Maryland Elevation Working Group Patrick Callahan
  - Patrick C—no updates
  - Pat M—looking to ID single point of contact. Will check with Roger to see if he can lead as a non-elected person
- o Business Entity Data Working Group Pat McLoughlin
  - Doug A is working to consolidate the document.
- o Geospatial Career Outreach Working Group *Tim Palmer* 
  - Looking to highlight new initiatives, like career outreach group. Looking to finalize objectives and strategic plan for the group. Possibly by next Exec Meeting. Reached out to previous students to participate in TUGis career outreach presentation. Working on list of volunteers and focusing on diversity. Also looking at second career GIS professionals to provide another look.
- Quarterly Meeting Updates Julie Spangler
  - o Winter Meeting Southern Maryland
  - Crofton Anne Arundel County Library. Start time will be 9:15-ish. Getting room for free, good parking, and food in reasonable distance. Looking for a breakfast sponsor at a couple hundred dollars (been about \$350). Want to change things up from Panera to a local bakery / bagel shop. In the past, sponsors could setup a booth. - Delmarva Conference (April 27, 2018)
  - o Patrick C. Sponsorships are more expensive than the booths; Booth is 650, sponsorships start 900, both include 2 complimentary tickets.
  - o Pat M. Is there a way to get a shot-out during the plenary instead of a formal sponsorship / booth?
  - o Julie What kind of ROI have we gotten in the past from participation? Is the cost worth it?
    - General discussion Not worth it, not enough ROI
- MD DoIT GIO Update Julia Fischer
  - o Pat M. 2019 is non-flight year, looking to issue new TLRP for imagery. Looking to have it out by Feb, and awarding / presenting to Numbers Board by end of year. One limitation is that the contract has stipulations that no longer makes sense. SaaS contract working through legal issues. Implementation of iMap 3.0 still underway.
    - Julie Is there a schedule for the agencies?
      - Pat M. Working through it, and will be meeting with each agency / TPU.
         Slight delay on final data for 2017 imagery acquisition, will be getting resolved soon and will be released soon. 2017 NAIP imagery available now.
         iMap portal will be streamlined and re-architected, including a more consistent bridge with Socrata.
