- 1. Open Meeting & Announcements Julie Spangler
  - Approval of Prior Meeting Minutes
    - November 2019

Shawn is going to review the meeting notes and cleanup the few bullets that appear to be unfinished. No one had any questions regarding the notes.

- New Topics & Open/General Discussion
  - Pat McLoughlin's last day at Maryland DoIT was on 12/10. He now works at JMT.
  - The Delmarva GIS Conference will be held in Dewey Beach in April. Registration is now open.
- 2. MSGIC Treasury Report Jen Chadwick-Moore Jen reviewed the treasury report and there weren't any questions.
  - 2020 budget planning

There is a <u>2020 budget spreadsheet</u> in Google Drive that estimates what we will spend in 2020 based on what we've spent in past years. The total income was estimated based on the average of the past few years (\$17,750.00). Jen added in the cost for website renewal.

We may want to spend more on training in 2020. As far as Julie knows, the TUgis fees are going to remain at \$4,000.00.

## 3. MSGIC Business

• Strategic Goals - Julie Spangler

**Hydrography Layer** - Roger would like to suggest a goal of identifying funding for an update to the hydrography layer for the State of Maryland. Is it woefully behind elevation, parcels, and other datasets. It's at the 1:24,000 scale and doesn't align with these other layers. Stormwater is becoming more important across the state. Julia Fischer will investigate whether the State is planning to do anything for hydrography.

**Engagement with GIS Professionals through MSGIC Website** - Shawn brought up the desire to drive more traffic to the MSGIC website by GIS professionals.

**Forum or Chat** - This idea has been brought forward by several people. It should be a topic of discussion for a committee.

Julie would like to make sure that we have enough people to support the strategic goals. It's difficult to make progress with only one person involved.



Julia suggested forming strategic partnerships with groups similar to MSGIC. We should be talking up each others' events, etc. An example of this is the partnership with Maptime Baltimore.

Website Working Group – Julie Spangler

There is a \$230 fee for TierraNet that we need to pay by the end of the month if we intend to stay with them. The website working group suggested that we switch to HostGator. The timeline for switching is next week. Julie will work with Shawn Lynn to find out how much it costs and then figure out how to pay for it. The working group is continuing to meet and will switch focus to the website content. They set up a Slack site.

Mara was able to get MSGIC setup with G Suite for nonprofits. She has been working with Shawn Lynn to get everything wired up. There will likely need to be a migration of the Google Drive docs to a new location. MSGIC will also need to be able to get an improved email address.
