New Topics & Open/General Discussion

Maryland Chief Data Officer Update - Pat McLoughlin

- Working to establish principles for data government
- A lot of this was included in the Executive Order that created Pat's new position

- Working on a statewide data inventory
- Working to establish a process for managing data assets across the state
- Have a federated environment -- no central organization is responsible for managing data
- Statewide strategic plan for next two years will be released to the public shortly on a website
- Strategic plan focuses on organization and governance, looking at overall maturity using CMMI, working with agencies to establish data strategies based on business strategies of those orgs, working on collaboration through MOUs, data sharing, and data use agreements
- Does not impact local governments, but could be used as a model
- Establishing a working group
- Would like to release a statewide standard in August
- Working to establish a statewide literacy program: intro to data course, data management professional course that follows DAMA/DMBOK, and executive level training course
- Will be putting together content on how to convey effective messages
- Looking to establish a data catalog across the state
- Will be a bridge between the business data and the operational/metadata -- make it more easy to search/discover
- Executive order made each state agency identify a single point of contact; this has been very helpful
- Have a roadmap and RACI matrix
- Pat welcomes feedback about the position and what's being done since it is brand new
- No requirement for the local governments to participate, but would like input/feedback from them
- A lot of states and counties have merged the GIO in with the CDO; silos are coming down

## **MSGIC Business**

MSGIC Treasury Report – Jen Chadwick-Moore

- Had more income from PayPal through memberships.
- Have to follow up with Delmarva again (they said they had found the check but haven't cashed in yet).
- Negative net income will change in the coming months.
- Still have a healthy account balance of \$29K.
- Working with the tax folks (we've changed from private foundation to public charity) to get the new forms that needed to be filled out. The goal is to have them prepared and paid for this year, so we won't have to pay for these services going forward.
