- We had our Open Source Watershed Modeling (first full-day training in a while)

Caucuses

Federal Caucus – Roger Barlow

- National Wildlife Federation: We had planned to collect data in some spots, particularly federal lands along the east coast and that would have involved southern Maryland and Worcester County. This project is off because the memorandum of agreement expired and nobody is able to renew it in time to get anything flown, so this is probably going to get postponed until next year.
- Potomac 2 Topobathymetric data from Shpeherdstown WV and Hancock MD is set for delivery later this month. Data looks really good. We did have an issue with some bias in the bathymetric data, but that was solved a couple of weeks ago and everything is on track. We will have 126 miles of Potomac River (from Little Falls, DC to Hancock, MD). We were working on another segment but funding was not available.
- Worcester Wicomico Somerset topographic LiDAR lower eastern shore has been delivered. Roger is working continuously on the Kent Caroline Talbot Dorchester, trying to confirm that it is going to be funded as part of the USGS Chesapeake Bay Science Support. We may, in terms of the next-generation 911 LiDAR coordination for the z-values and building outlines, leverage that to QL1 for one or more counties depending on the estimate which Roger will send in as soon as he can confirm that that project has been given the green light.
- The 3D elevation program is on vacation this week.
- We did have a meeting on Friday with various folks in the elevation community to talk about the next-generation 911 requirements and trying to get that leveraged. The idea being to leverage the Kent Caroline Talbot Dorchester project as kind of a pilot project; the logic is that these counties don't have the intense building count that the City of Baltimore or Baltimore County would have.

State Caucus – JB Churchill & John Lesko

- John: The eastern shore imagery pilot data has been delivered. Two pilot areas: (1) Cecil contained 3-inch pixels and 6-inch pixels, and (2) Salisbury - in the process of going through that imagery. We anticipate that we will give Sanborn the go-ahead and finish up DAT and get the production underway for the imagery. Their target is to have that all wrapped up by the end of the year and start having that available on MDI Map sometime during the beginning of next year.
- Expanding on Roger's updates: We finished up the derivative products for PG, Montgomery, and Cecil County so that data is on MDI Map.
- ESRGC has plotted out the data for five counties that we will start working on next fiscal year to get those derivative products. Also, the data for three counties in western Maryland (Frederick, Washington, and Allegany) will be coming in. – These





- eight counties are QL2 so they go a little faster. PG County and Montgomery County were QL1 (therefore a little longer to get through).
- As a state, we need to make sure that we have the infrastructure in place to start handling these larger datasets. As Roger said, we met on Friday. The effort is to initiate a statewide LiDAR program (much like we did with the orthoimagery program). Trying to get the 911 board to fund (all, or at least some), trying to work with Roger and USGS to see what kind of partnerships we can forge going forward. USGS will fund up to a certain percentage of QL2. If we decide to go to QL1 with the state, the 911 board, or other partners - exploring if we can bring other agencies into the mix. Don Baldrich from Mission Critical Partners is spearheading this, so if anyone has any suggestions, get in contact with Don.
- The reason the 911 board is getting involved is that they are now mandated to have elevation for each building for the 911 response. We're doing automated extraction of building rooflines
- We are also thinking about a pilot area (as Roger said, there are 4 counties in the eastern shore that we are trying to get funded for next year) to make sure this 3D roofline technology will work. So we are thinking about using some of the PG County and Montgomery County (QL1) data to create a pilot area out of that.

- Josh put together the presentation for next week and Varun will be delivering it. We have updates from Anne Arundel County, Annapolis, the City of Hyattsville, and Montgomery County; have not heard from any others as of yet but hope to soon in order to add them to the presentation.
- Offered to present for future Quarterly meetings.
- We have recently developed some field apps for inspections as part of the Stormwater Infrastructure Program, as well as inspections and permits for private infrastructure.
- Thinking about inviting a young professional from his company to the MSGIC Executive Committee meetings.
- Varun: Spoke to his different groups in Montgomery County, working with Josh to add them to the presentation.

Other Discussion – Pat McLoughlin

- Keynote speaker at TUgis
- We released a 2-year statewide strategic plan which includes a number of different initiatives that we're looking to carry out in parallel. (1) Statewide data terminology and glossary, (2) looking to release data governance framework to the general public in the next couple of weeks.
- We have a couple of different contracts that we are looking to secure (can't go into too much detail right now) and get through the evaluation process over the coming months. This will allow us to carry out some of the other initiatives that we are looking to put in place; that includes the Data Literacy program (where we've got training available to varying levels of experience throughout the entire state), Data Management Maturity Assessment, and some other as-needed services.
- All of this information will be made available through the CDO (maryland.gov) website, in the next week or so.
